

Sub: Application for Letter of Permission for functioning Laxmiben Homoepathy Institute and Research Centre Lalji Park, Mehsana -Unjha Highway, At &Po- Bhandu, Gujarat- 384120 with intake capacity of 100 seats in BHMS course during A.Y. 2024-25 regarding.

Laxmiben Homoepathy Institute and Research Centre Lalji Park, Mehsana -Unjha Highway, At &Po- Bhandu, Gujarat- 384120 functioning since 2017, has submitted application for conducting BHMS course with intake capacity of 100 seats for the A.Y. 2024-25. The college has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

College has not enabled the Aadhar Enabled Biometric Attendance System (AEBAS). Same may be implemented within one month of time.

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number etc. Diagnosis shall be written as per ICD-11criteria. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history as per Homoeopathic Principles and made available in Medical Record Room for academic purpose of students and follow up of patients.

Considering the above observations and facilities available, MARBH has decided to Issue Conditional Permission for Laxmiben Homoepathy Institute and Research Centre Lalji Park, Mehsana -Unjha Highway, At & Po- Bhandu, Gujarat- 384120 functioning with intake capacity of 100 seats for BHMS course during A.Y. 2024-25.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 Seats for BHMS course shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in Compliance to MSR 2013 anytime during the academic year.
